RESIDENTIAL SERVICES: SOJOURNER CENTER'S CRISIS SHELTERS PROVIDE A SAFE AND CONFIDENTIAL LIVING ENVIRONMENT, STAFFED 24 HOURS PER DAY, 365 DAYS PER YEAR FOR WOMEN AND CHILDREN WHO ARE FLEEING A DOMESTIC VIOLENCE SITUATION. PROVISIONS OF SHELTER, FOOD AND CLOTHING ARE PROVIDED UPON ARRIVAL AT THE SHELTER. CASE MANAGERS SUPPORT THE WOMEN AND FAMILIES IN THEIR PROGRESS TOWARDS INDEPENDENT SOCIAL AND ECONOMIC STABILITY THROUGH A VARIETY OF SERVICES INCLUDING EDUCATION CLASSES, SUPPORT GROUPS, SAFETY PLANNING, LICENSED ONSITE CHILDCARE AND HEALTHCARE, LAY LEGAL ADVOCACY SERVICES, LIFE SKILLS DEVELOPMENT AND WORKFORCE READINESS. IN FY 17, WE PROVIDED 33,722 NIGHTS OF SHELTER.

IN FY 16 THE CDC ACHIEVED A 5 STAR RATING FROM QUALITY FIRST; THIS IS THE HIGHEST RATING POSSIBLE.
