ALL BASIC NEED ITEMS ARE PROVIDED UPON ARRIVAL AND THROUGHOUT THE INDIVIDUALS STAY AT SHELTER. CASE MANAGERS SUPPORT PARTICIPANTS IN THEIR PROGRESS TOWARDS HEALING AND INDEPENDENCE THROUGH A VARIETY OF SERVICES INCLUDING PSYCHOEDUCATIONAL CLASSES FOCUSING ON TRAUMA, DOMESTIC VIOLENCE EDUCATION, SAFETY PLANNING. ADDITIONAL SERVICES INCLUDE A LICENSED ONSITE CHILDCARE, LAY LEGAL ADVOCACY SERVICES, LIFE SKILLS DEVELOPMENT AND WORKFORCE READINESS AS WELL AS ACCESS TO ONSITE HEALTHCARE PARTNERSHIPS.

TRANSITIONAL HOUSING: THE TRANSITIONAL HOUSING PROGRAM PROVIDES INDIVIDUALS THE OPPORTUNITY TO GAIN THE SKILLS AND RESOURCES NECESSARY FOR OBTAINING AND SUSTAINING SAFE PERMANENT HOUSING. PARTICIPANTS WORK WITH THEIR ASSIGNED CASE MANAGER TO DEVELOP AN INDIVIDUALIZED GOAL PLAN. TO ACHIEVE THEIR GOALS, PARTICIPANTS HAVE ACCESS TO SOJOURNER CENTER'S COMPREHENSIVE CONTINUUM OF SUPPORTIVE SERVICES, WHICH FOCUS ON THE MOST CRITICAL NEEDS RELATED TO SELF-SUFFICIENCY: FINANCIAL LITERACY, MANAGING A HOUSEHOLD AND BUDGETING, EDUCATION ATTAINMENT, AND WORKFORCE READINESS.

CASE MANAGERS MEET PARTICIPANTS WHERE THEY ARE, OFTEN AT A SAFE PLACE IN THE COMMUNITY, TO PROVIDE SUPPORT RELATED TO DOMESTIC VIOLENCE AND TRAUMA. THE COMMUNITY OUTREACH PROGRAM ALSO PROVIDES PRESENTATIONS FOR COMMUNITY ORGANIZATIONS INCLUDING SCHOOLS, HOSPITALS, AND LAW ENFORCEMENT AGENCIES. SOJOURNER CENTER ALSO PARTICIPANTS IN MANY TASK
